

## **League of Women Voters of Curry County Work Force Housing Project**

The League of Women Voters of Curry County has completed a project evaluating the availability of affordable work force housing in Curry County. The project was designed to answer the question "Is there an adequate supply of work force housing in Curry County to support economic development, whether through growth of existing businesses or attraction of new businesses?" LWVCC is making the project results available to all interested parties.

### **What is Work Force Housing?**

Work Force Housing (WFH) is housing that is affordable by workers in the lower half of the pay range of local employers. Since a business can only operate in this area if all of its employees can afford to live here, the supply of work force housing is a critical factor in economic development.

### **The LWV Project**

From 2009 through mid 2011, the LWVCC has conducted a series of interviews to assess the balance of supply and need for WFH. Structured interviews were conducted in two categories: Employer Interviews and Targeted Interviews (real estate agents, financial institutions, builders, business associations and government agencies). Qualitative and quantitative responses were recorded, analyzed and displayed.

### **Project Findings**

- There is a clear shortage of WFH in Curry County.
- This shortage creates problems both for current area employers and for economic development.
- Provision of additional WFH would be a definite asset to the County.

## **MAY UNIT MEETING REPORT**

“Ocean Frontiers,” a colorful and informative film, was shown at both Unit Meetings in May. The DVD begins and ends with Port Orford people explaining the process used to get a Marine Reserve and Marine Protected Area established. The second segment described how environmentalists and shipping companies cooperated to protect whales in Boston Harbor. The third segment showed how the coral reefs in the Florida Keys are being cared for. The fourth segments showed how Iowa farmers learned how their agricultural practices impact the Mississippi River and Gulf of Mexico and how they could improve the situation.

## **THE VALUE OF VOTING**

Port Orford’s Theatre 101 is in the process of preparing a Reader’s Theater event to be held four times beginning July 4. The working title is “The Value of Voting” and features people and events involved in the struggles to gain voting rights for all Americans. They want to include the League of Women Voters in these events. Tentative schedule is July 4, 5, 6, and 7 at 7:00 p.m. The LWVCC Board decided to support the endeavor and try to get our members to help with registering voters at the theater during intermission. ## **LWVOR COUNCIL**

*Editor's note: Jan and Warren Krick were the Curry County League's delegates to State Council in Eugene on May 11 and 12. Here is Jan's report.*

We very much enjoyed the collaboration and camaraderie of League members from all over Oregon. The purpose of State Council is for the LWVOR Board of Directors to connect with local Leagues between convention years; that is, every other year. A formal call is made by the president of LWVOR to presidents of all local Leagues, directors and members at large to meet to elect the second vice-president, treasurer and three elected Board members as well as give guidance to the Board on programs and methods of work, and to approve the State’s annual budget.

It sounds like work and it was, but it was also fun exchanging ideas and hearing what other Leagues are doing. Our Curry County League generated interest and admiration for our past work on Homeless and Runaway Youth and the Judiciary State studies. Our recently completed Workforce Housing project has caught the eye of many local leagues in Oregon, as well as our proposal for a national study on lobbying. I received a call from LWVOR President Robin Wisdom as we were preparing for the trip asking me to speak about our proposal and my recent telephone conversation with LWVUS lobbyist Betsy Lawson. Imagine my surprise when I found that I was first on the Council agenda!

Also on the minds of League members in Oregon is a State restudy, presented by the Education Fund, on Children at Risk. As a result of our participation in the 2006-08 Homeless and Runaway Youth study that netted Oregon programs \$900,000 in state-funding, we in Curry County have been asked to take a role in this restudy. On a less celebratory note, because League membership rates have fallen statewide, a new membership development program is being funded at the national level that will bring trained coaches to any Oregon League that requests help in raising awareness and membership locally. We can be very, very proud that in Curry County membership is up whereas, statewide, it has fallen by 21% since 2010. I want to thank all of you for your loyalty and commitment to what the League of Women Voters does in our community, state and country to keep the populace informed and educated concerning political issues that affect our lives. We also talked about the success of Vote411, Election Year 2012, Coastal Natural Resources, and the celebration this year of a century of voting rights for Oregon women.

## **Vote411 Provided Candidate Information During Primary**

The League of Women Voters online Voters Guide - Vote411 - was a great success during the Oregon Primary Election. It presented non-partisan information for every contest on each voter's ballot. After supplying their home address each voter received a ballot tailored specifically for them.

Looking ahead to the General Election in November each voter will be able to study and compare candidate biographies and answers to important questions. All answers will be provided by the candidates. No spin. No negative ads. Just the unbiased information needed to make these important decisions. Voters will be able to print their choices to simplify filling out their ballot.

After you supply your home address click on the "Find My Races" button. Verify that your address is correct and all of the races that will appear on your ballot will be available.

## **Proposed Membership List Distribution Plans**

Your Board wants to make sure that each member has ready access to a membership list to help members contact each other. We want to avoid the expense of printing and mailing the list. At the same time we want to protect each member's privacy. Here is what we propose:

- We will send out a membership list as an addendum to our July/August *Coast Lines*, which is published on about August 15.
- Members will be able to contact the Membership Chair prior to August 1 to request that some or all contact information (address, phone number or email address) be omitted from the list.

We will discuss this proposal at the Annual Meeting and agree on a policy.
