Was your vote COUNTED?

I have voted in ten different states. Most of my voting experience has been the same from state to state, show up at the poll and vote, or fill out my ballot and drop in a dropbox. I'm done. I wait for the election results. That is not the experience of everyone. The first time my daughter voted in Alabama, she rushed to the polling place in between her law classes. The line was short, but when she got to the desk to get her ballot they told her the voting card she had been sent in the mail had the wrong polling place listed, she had to go to another polling spot several miles away. She quickly jumped in her car and drove to the next spot. The line was out the door and around the block. No way she could stay there and make her next class.

After class, she went back and stood in line for hours to make sure she could vote. Unfortunately, this is normal for a lot of people. This year, instead of just voting, I wanted to find out more about the process. Through League of Women Voters, I now know about the Vote411.org website, and not only checked to see if my voter registration was current, but helped a divorced friend update her voter information to reflect her name change. I used the Vote411.org site to learn about candidates that I did not personally know and had not received any political mailings for. After I voted, though, I saw news articles about drop boxes in California that had been vandalized, or ballots found in places they shouldn't be, and wanted to know that my ballot had been received and counted.

- **6** To find out if your county's supervisor of elections has received your ballot, go to the Oregon Secretary of State's website https://sos.oregon.gov/voting-elections and click on MY Vote.
- 6 Enter your name and birthdate, and it will tell you if your ballot has been received, and when.
- If you mailed your ballot in, you will need to wait up to five days to give the postal service time to deliver it. If you have waited and your ballot does not show up, then you should call the County Supervisor of Elections Office (541-247-3297) and they will help you.
- I checked my ballot, it had been delivered, but this site does not say if your ballot has been verified.
- 6 If your ballot is not verified, the County Election Office will mail you a letter telling you why it was not verified and what steps you need to take to correct it.
- You can also call the number above and the County Supervisor of Elections Office can tell you if your vote has been verified.

How to Check Voter Turnout in Curry County

Are you curious as to how many registered voters in our county are actually voting? Go the Curry County Clerk website (see link below), click on election division, and then current election information - scroll to the bottom of the page and click on ballot return, you will be able to see a summary of what is coming in to the election office and how many ballots have been verified. Again, if your ballot is in a pending status, you will be notified by mail.

The forums were very informative and the candidates' discourse was civil and gracious. The League thanks everyone involved. It took much time and effort, but was worth it. We hope that you learned about your choices so that when you voted, you were better informed.

Additionally, the League's <u>Voter Guides</u> were distributed to centers at each of our three cities. Candidates were entered in VOTE411 by Voter Service. Each candidate was asked to write a brief bio so that the voters could access vote411.org to prepare for voting. About 60% of the candidates took advantage of this.

Also, Voter Service registered the most voters we ever remember registering on National Voter Registration Day (September 22, 2020). Tables were set up in Brookings at the Chetco Library; in Gold Beach at McKay's Grocery and in Port Orford at Rays Grocery Store. Again, our gratitude is extended to these businesses for help in registering voters. Our County Clerk, Renee' Kolen was running between the three cities picking up newly filed registration forms.

There will be much to discuss as we process the national, state, county, and local election results. It will be especially important to determine how these results will impact the future actions and goals of the LWVCC.

Below, we have listed the 2019-2020 LWV-Oregon Legislative Priorities. At its July retreat, the LWVCC Board decided its focus should be on three of these areas: Climate Emergency, Protecting Democracy, and Anti-Poverty & Health Care Reforms and we are actively involved in LWVOR's Climate Emergency efforts. We want everyone's input on these issues. Which of these priorities are the most important for those of us here in Curry County to pursue? Or is there another priority for LWVCC?

We will email the information about how to join the meeting two days before the Zoom meeting.

Please plan on attending! Your input and ideas are needed as we move forward in this momentous time.

2019 – 2020 LWV Oregon Legislative Priorities

- Climate Emergency Advocates for a variety of policies and budgets to reduce risks and plan for adaptation where needed relating to the United Nations Intergovernmental Panel on Climate Change (IPCC) recommendations.
- **Protect Democracy** Advocates for governance issues including ethics, efficiency, citizen participation and access, public records and meetings law, and contemporary privacy and technology issues. Elections policies include campaign finance reform, laws and administrative rules, and redistricting.
- **Support Mental Health** Addresses social policy areas that focus on mental health.
- Anti-Poverty and Health Care Reforms Actively lobbies for anti-poverty programs to help low income and at-risk people move toward financial stability.
- Promote Public Safety Measures (Corrections and firearm reform) Addresses social policy areas including adult corrections, judiciary, juvenile justice, public safety, and gun safety.
- 100-Year Water Vision Promotes a clean and abundant water supply for all.
- Generate Adequate Revenue (Tax reform) Addresses fair, equitable, and stable tax and revenue policies to adequately fund services and functions critical to Oregonians.




