# Voter Registration \* by MJ Labelle

Curry County registered a total of 32 new and updated voters, including some fire victims who had to relocate. Additionally, we handed out 43 registration forms for people to take home to fill out. This was the largest number of registrations any of us could remember in our years of working with the National Voter Registration Coalition. The League is only one of the many organizations that participated on September 22, 2020.

Nationally, 1.5 million new or updated voters were registered. This was a record-breaking year with over 4500 community partners and 100 premier partners helping register voters.

We are PROUD of the effort and thank Renee' Kolen, City Clerk, for running up and down the coast to bring us more voter registration forms because we were running out! Thanks to:

# November 2020 Ballot Measures \* by MJ Labelle

There are four ballot measures on the November 3, 2020 Oregon Ballot, summarized below along with the Oregon League's position. There is a power point on our website <u>www.lwvcurry.org</u> that describes each.

# 1. Measure 107. Constitutional Amendment: Campaign Finance Limit

Amends Constitution: Allows laws limiting political campaign contributions and expenditures, requiring disclosure of political campaign contributions and expenditures, and requiring political campaign advertisements to identify who paid for them." Campaign finance reform has been an issue at all levels of government elections for many years. LWVOR has supported contribution limits for local and state elections whenever there has been the opportunity. This is a referral from the Legislature and is a Constitutional amendment. Until a recent Oregon Supreme Court decision, courts had held that the Constitution's free-speech provision was contrary to contribution limits. This ballot measure will make sure that campaign contributions are not speech and that campaign contribution limits may be imposed.

League Position: SUPPORT

2. Measure 108. Statutory Amendment: Increase cigarette/cigar taxes & create tax on nicotine inhalant devices

Another legislative referral, that "Increases cigarette and cigar taxes. Establishes tax on e-cigarettes and nicotine vaping devices. Funds health programs." It will help to stop some young people from taking up unhealthful habits. Oregon's taxes on these items are below those in Washington and California. This will raise the taxes to be on a par with those states.

# League Position: SUPPORT

**3.** Measure 109. Statutory Amendment: Allows manufacture, delivery, and administration of psilocybin

"Allows manufacture, delivery, administration of psilocybin at supervised, licensed facilities; imposes two-year development period." The League has no position to support or oppose this ballot measure **League Position: NO POSITION** 

# 4. Measure 110. Statutory Amendment: Drug addiction treatment and decriminalization

"Provides statewide addiction/recovery services; marijuana taxes partially finance; reclassifies possession/penalties for specified drugs." Finally, after much conversation, the Board voted to support this measure. **The League has several positions on which to base its support, including:** 

- LWVOR Health Policy, Adult Mental Health in Oregon (1987, 2001, 2008): This position states that the mental health delivery system should include adults with alcohol and drug addiction and that the concept of care, treatment, and support should occur "in the least restrictive environment possible."
- LWVUS Sentencing Policy (2012): Alternatives to imprisonment should be explored and utilized, taking into consideration the circumstances and nature of the crime. LWVUS opposes mandatory minimum sentences for drug offenses."
- LWVUS Principle: "No person or group should suffer legal, economic, or administrative discrimination."

There is a long list of organizations working toward racial justice that support this measure. The Board concluded that because people of color make up a disproportionate group of those who are incarcerated, many for drug related charges, the League should stand in solidarity with them in supporting this ballot measure **League Position: SUPPORT**

# Ruth Bader Ginsburg 1933 - 2020

The following is a verbatim excerpt from an obituary of Justice Ruth Bader Ginsburg, born Joan Ruth Bader, which appeared in The Week, October 2, 2020, at page 35; most internal quotation marks and substantial portions of the text have been omitted.-

**RUTH BADER GINSBURG** changed the legal landscape for American women. In a career spanning six decades, she became the nation's leading court advocate for gender equality, first as a civil rights litigator and then as the second woman ever to serve on the Supreme Court. ...Along the way, the quiet, bookish jurist became an unlikely pop-culture icon. Her stern image – with judicial robe and lace collar – was stamped on T-shirts and tattooed on arms, often with the nickname Notorious RBG.

As the Supreme Court veered right after the retirement of Justice Sandra Day O'Connor in 2006, [Ginsburg] dissented more often and more assertively. In 2013, Ginsburg assigned herself an angry dissent when the court struck down a key provision of the 1965 Voting Rights Act .... Axing the law's protections against voter suppression when they continued to work, she wrote, "is like throwing away your umbrella in a rainstorm because you are not getting wet." She held out hope, she once said, that some of her dissenting opinions might sway a future court, extending her considerable influence yet further. "I will not live to see what becomes of them," she said, "but I remain hopeful."

# Civil Discourse - Reducing Political Dysfunction & Incivility

# On September 17, I attended a fascinating zoom webinar, **"What Will It Take to Rebuild Our Civic Trust To Save Our Democracy?"**

It was hosted by the Wheaton (Illinois) LWV and by the National Institute for Civil Discourse. NICD was started in 2011 by George H.W. Bush and Bill Clinton and has many luminaries on its board. The webinar included insightful remarks by NICD's Dr. Carolyn Lukensmeyer, followed by participants' questions and break-out sessions.

According to Dr. Lukensmeyer, trust historically erodes at the structural level. As examples, she cited longstanding hyper partisanship and more recent concern over the integrity of the vote process. Once broken, she relayed, trust can be rebuilt only "thimbleful by thimbleful."

On the behavioral level, Dr. Lukensmeyer recommended engaging with those who hold different views. She offered four practical suggestions for such conversations. (1) Strive to understand the other person's view, rather than trying to change it. (2) Identify something you're curious about; start with an open mind. (3) Change the percentage of time spent talking versus listening; become comfortable with moments of silence; bring back the old-fashioned rhythm of conversation. (4) Increase your skill at perceiving nonverbal cues.





Responding to participants' comments about fears and hopes, Dr. Lukensmeyer focused on concerns over the 2020 election. She identified two crucial periods, before and after the election.

Pre-election, the key is voter registration and getout-the-vote. The best way to buid trust is by making this the largest, most inclusive election, including youth participation. Actions include working polls, combatting voter fraud misinformation, and protecting the post office.

Post-election, the key will be overcoming the belief – regardless of outcome – that the election was "rigged." We need to be ready with facts, engagement, and outreach, while recognizing existential threats like the pandemic, climate change, and social unrest.

Despite the challenges ahead, the webinar offered avenues for action and hope. I for one am hopeful, for an outspoken liberal justice like Ruth Bader Ginsburg could become close friends with her Supreme Court colleague, rock-ribbed conservative Antonin Scalia, then the rest of us can surely find a way to reach across the divide.



# Climate Emergency Update \* by Louise C. Abbott

# The LWVCC is providing this information because Climate Emergency is a priority for the League – at the state level and as adopted by the LWVCC.



Many Oregon residents demand to have more information about the causes of the recent fires in Oregon and factors that resulted in the exacerbation of these fires. The Oregonian's Ted Sickinger wrote a story documenting that at least some, if not many of the recent fires in Oregon, were power line ignited. Here is the link to that story.

Several points of summary from the Oregonian article, information from individual Oregon residents who have been affected directly by these fires, and a Seattle Times article noted below, include:

- Downed power lines appear to have been involved in some, if not many, of Oregon's recent fires.
- Cutting trees, either sustainable or restoration, is not likely to have a significant impact on westside Cascade forests (or elsewhere) in improving the safety of people in these wind- and drought-driven events. Here is a comment from Dominik DellaSalla, "Thinning trees in the backcountry, that won't make the difference. We need to spend the money to fire-harden our communities." DellaSala is the chief scientist for Wild Heritage, a forest conservation project of the Earth Island Institute, an environmental nonprofit. This information came from the following article in the Seattle Times.

- The Seattle Times article also pointed out that the fire that burned Talent and Phoenix had nothing to do with the management of thickly forested Northwest mountain slopes. "It started in a patch of grass by a dog park in Ashland's north end on a hot day with fierce, dry winds. The fire raced through a county greenway park, chewed through roadside brush, and jumped into the heart of two communities Talent and Phoenix, with a combined population of more than 10,000. Then houses, trailers, and commercial buildings became the fuel that fed its relentless advance."
- Finally, also from the Seattle Times article, "This fire season has demonstrated, yet again, that many fires in the West burn largely in shrub and grasslands, which can easily and rapidly carry flames into housing developments. And, DellaSala is urging post-fire legislation be narrowly targeted. He wants more public funds spent and tax credits offered to build communities better able to survive such fire."





I conclude that the best strategies continue to be preparing homes and communities for fire, including home "hardening," creating appropriate, defensible space around homes and other buildings, and protection from smoke. Unfortunately, many of these strategies are easier said than done. However, the sooner we address these issues in a meaningful way, the sooner we can protect our communities from future, yet inevitable fires.

# Timber Tax Fairness \* by the Board

Here's information about an upcoming event, which is not League-sponsored but may be of interest to LWVCC members.

You're invited on a Zoom call, Wednesday, Oct 21, 6:00-7:30 PM for a discussion of "Timber Tax Fairness: Revenue Restoration for Rural Oregon Jobs, Water, and Wildlife."

The event is intended as a community conversation about revenue restoration, tax fairness, funding essential local services, and protecting drinking water. A group of coastal residents is hosting this event. That group is "exploring ways to reinstate fair timber taxes to fill the hole left in Oregon's rural county budgets created by the elimination of the tax that helped to pay for county services." Among those efforts is an appeal "to the State legislative counsel to draft legislation which would reinstate timber taxes to 1996 levels and redirect that funding to local communities.

It would also provide a tax reduction to those companies that switch to more environmentallysound forestry practices" to help mitigate the effects of climate change. Guest speakers for the event include Jody Wiser, tax policy expert, Tax Fairness Oregon; Richard Felley, retired water district manager and past director of Tillamook Estuaries Partnership; Mary Scurlock, water policy expert and advisor on Oregon State University Trees to Tap Report. They will include opportunities to ask the speakers questions and to learn about possible solutions.
