Here's some interesting information about Labor Day, courtesy of History.com:

Nowadays, many Americans see Labor Day as time off work, an opportunity to enjoy a barbecue with friends and family, and a final moment of summertime relaxation before the busy fall season begins. But the history behind the Labor Day holiday is far more complex and dramatic than many realize.

- It all started with a heated campaign by workers in the late 19th century to win support and recognition for their contributions. Throughout the 1880s, labor strikes became increasingly common, with workers protesting their long hours and their difficult, dangerous working conditions.
- In September 1882, New York City's Central Labor Union organized a parade through Lower Manhattan, joined by a large crowd of some 10,000 to 20,000 people. Other cities followed New York's lead in holding celebrations for workers in early September.
- ★ In 1887, Oregon became the first state to make Labor Day an official holiday. 22 other states followed over the next seven years.
- ★ In 1894, President Grover Cleveland finally signed legislation creating a national Labor Day holiday in early September. Ironically, just days later, he sent federal troops to Chicago who brutally crushed a strike by railroad and Pullman sleeping car company workers, leaving some 30 people dead.

need your help!


National Voter Registration Day, by Dennis Triglia, Voter Service Chair

Welcome to the Team!

I grew up in Akron Ohio, and as a child we drove to the beaches on the east coast every summer to vacation. We stopped many times to tour monuments in Washington DC, and homes of Presidents Washington and Jefferson.

My father, a navy veteran who served in WWII, wanted to show us the Capitol, and my mother, a genealogist, wrote about and connected my family with history in a very personal way. They both had a strong sense of optimism about the future. They instilled in me and my siblings a strong sense of responsibility to care for the world around us. I must have taken that to heart because I earned a degree in Geography and City Planning.

After graduation I found work as a planner in Missoula, Montana, and later as a researcher, writer and facilitator for rural land and water conservation entities. There I saw first-hand how students changed the trajectory of their lives by investing time and energy in certificates and degrees. Now retired in Brookings, I serve as a volunteer on the Board of SWOCC's Foundation and on Southern Oregon Climate Action Now, Coastal Chapter.

My DIY projects include gardening, basketry, and art of many types, and I share these pursuits with my grandchildren.

News From National

The following information is from the "Newsroom" at the LWVUS website.

- In May 2022, the Missouri Legislature passed a restrictive election law, HB 1878.
- ➤ It was signed into law by the governor in June. That law is now being challenged in court.
- In two separate lawsuits, the League of Women Voters of Missouri, together with the Missouri NAACP and two individual voters, allege that the newly enacted voting restrictions violate the Missouri Constitution.
- ➤ The first suit, filed on August 22nd, challenges the law's voter registration and ballot assistance restrictions.
- The second suit, filed on August 24th, challenges the provisions of HB 1878 that would eliminate forms of identification that Missourians currently rely upon to verify their identity at the polls.
- ➤ Those suits are pending.

News From State League

In her latest newsletter, LWVOR President Rebecca Gladstone highlighted several current issues of interest.

Among them was a report on the four measures that will appear on the Oregon ballot in November.

That report is excerpted below.

OREGON BALLOT MEASURES

Four measures will be on all Oregon ballots this November, and this is where the state League stands on them. The League studies issues, reaches member consensus, and then we adopt positions. We refrain from supporting or opposing measures if we have not studied the issue. The LWVOR board voted to accept the Action Committee recommendation for the following:

- #111 Oregon Right to Health Care Amendment SUPPORT [Legislative Referral 111] Amend the Oregon Constitution: The State must ensure affordable healthcare access, balanced against requirements to fund schools and other essential services.
- *#112 Remove Slavery and Crimes from the Oregon Constitution SUPPORT
 [Legislative Referral 112] Amend the Oregon Constitution: Remove language allowing slavery and involuntary servitude as punishment for crime. This legislative referral applies to prisoners working without getting paid.
- #113 Oregon exclusion from re-election for absenteeism NO POSITION
 [Ballot Measure 113] Amend the Oregon Constitution: Disqualify Legislators with ten unexcused absences from floor sessions from holding the next term of office.
- #114 The Reduction of Gun Violence Act SUPPORT [Ballot Measure 114] Requires permit to acquire firearms; police maintain permit/firearm database; criminally prohibits certain ammunition magazines.

And of course, if you have other meeting ideas, we'd love to hear from you about those, too.

Please bring your suggestions to the September unit meeting, which will be a virtual Member Round Table. If you don't "zoom," there's always an option to phone in. We'll explore member preferences about a number of league topics – including the kind of meetings you want. Please come – we need your input!

Youth Outreach

For some time, LWVCC has been looking to broaden its outreach to include high school students. We started by contacting local high school teachers of civics, history, and government, in order to connect with their students, our future voters. We've invited these teachers and students to our monthly all-unit member meetings. Despite a tepid response, we'll continue extending invitations. And we'll try other avenues as well, perhaps even voter registration on high school campuses in the future. We'd love to find mutually beneficial connections between the League and prospective young voters. Your ideas are welcome!

Youth outreach is also a focus state-wide. Among other things, the League of Women Voters of Oregon is sponsoring the 2022 Oregon Student Mock Election (OSME). It will take place October 18th, with ballot choices from Oregon's November 2022 mid-term elections.

Community Outreach

As circumstances permit, LWVCC is looking forward to greater participation in community events, such as the County Fair and community festivals.

And of course, National Voter Registration Day is just around the corner on September 20th. Please volunteer for this important (and fun) grassroots civics event.


