## Philip Dickson Biography

Phil Dickson joined the LWV because of the Home Rule Charter forums the Curry League ran a few years ago. " As a debater in those forums I was impressed at how it was run. I am also impressed with how the LWV impacts issues with professionalism. It is an organization I am proud to be associated with", says Dickson.

Phil grew up in the Dallas/Fort Worth area and at 18 moved to NYC where he worked for 3 years for the Woolworths Co. doing computer work while attending classes. He then

transferred to N. Texas to work in the Footlocker program. He was offered a job in London and also worked in the Middle East (Saudi Arabia), Europe and N. America as a computer technician at International Airports. He became the Dean of CCI Computer College in N. Texas for 2 years and started his own business which he ran for 14 years as a federally licensed International Cargo Broker. Phil is married to Pamela and has two boys 13 years and 9 years. In 2009 one of his sons was diagnosed with an illness and they needed to move. They chose Gold Beach which is home. He is now a computer technician for Curry County.

Phil has been active in Gold Beach in local theatre, has been Vice-President of Gold Beach Little League and President of the Mat Club. He also served as a Board Member for the Curry Anadromous Fish Club. He is a wonderful addition to the LWVCC and is training to be a moderator for the fall candidate forums as well as agreeing to serve as our President for 2016-17.

## 3 Homeless Resources Forums

### Port Orford - Lisa Harrison

Wow- the room was full of concerned citizens. !!!

Port Orford residents (37) attended the Homeless Resource Forum at the Port Orford Library March 8<sup>th</sup>. Resource Speaker/Advocates (11) introduced themselves and relayed to the group how their agency/organization provides guidance and help for the homeless citizens in the Port Orford area. A consistent comment from Advocates was that the Federal Government is NOT going to help and NOT to wait for the State to help. We need to collate as a community, secondly as a county, then we can apply for Federal help. These speakers also taught us how homeless are counted and the different categories.

One of the homeless in Port Orford told us her story and asked us to provide/help the homeless with the following needs: Water, toilet paper, trash cans and somewhere covered to cook. She touched many of us with her humility and asked us to not ignore homeless, they already feel invisible. Another homeless person talked about tent/cabins for the homeless in other states.

We had neighbors/residents tell us their stories of family homelessness and the effect, others asked how to drop off old cell phones for homeless use. We could feel the compassion in the room. At conclusion of the forum, the League leader members asked the attending citizens to make contact with the Speakers/Advocates and ask how they can help.

#### Brookings/Harbor - Connie Hunter

I think the League of Women Voters event tonight at Southwestern Oregon Community College went very well. Some of our panelists canceled because of illness but others came forward and stepped up to the plate. We had a total of nine panelists. Audience attendance was right around 30 to 35.

I don't see how it could've gone any better! I'm sure you will get feedback from others, but my personal opinion of the event is other then having a few more people attending, the quality and the nature of the conversation around homelessness was profound and impactful.

### Gold Beach - Lucie La Bonté

I was impressed with the conversation at the Gold Beach Forum. Phil counted 51 attendees.



The most obvious obstacle to housing is the HUD cap on rent allocations, which is less than what low rents are in Curry County. The Vietnam Veterans Chapter wanted to add to the HUD Funding but that is a federal



offense! Instead the VVA is collecting donations to put people up in housing or motels and working outside the government.

Mary Rowe who was homeless for 10 years has worked tirelessly with groups and state agencies on issues and on the Annual Homeless Count. She said there are no public showers in Gold Beach.

Chief Dickson, (above with Connie Hunter and Jay Trost) said homeless people are clean and want to be clean. They are seen using the fountain in the pocket park. He said the worst situation is that there is no place for people to go when they are released from the jail, usually for a small crime involving medication or alcohol abuse. Releases take place in the middle of the night when there is a violent criminal jailed. Folks are also released at times from the hospital. With taxi service to the nearest shelter being \$75 the City of Gold Beach does their best to work with folks and hands out bus passes but there is no service at night. Lt. Espinoza from the Sheriff's Department says they are working to address the underlying behavior of offenders with programs to reduce recidivism. There is a percentage that do not want resources.

Gold Beach has its angels, Lila Thorp who works at the Food Bank feeds folks and is finding housing for people. Nancy at the Fairgrounds collects and hands out goods. Juvenile Director, Jay Trost, who has been homeless, is concerned about the high rate of homeless youth and would like to see a "Tiny Home Community" built. The Agness Store donates day old bread and vegetables to the food bank. One thing was obvious, this community is working together and I hope solutions are in view!
