## **Choosing How to Choose:**

# **Election Methods Update!**

Libby Medley, Program/Events Chair, Clackamas County

With the 2016 Election over, our Oregon League is using a statewide study to reflect on the experience from a procedural point of view.

**Were you a sincere voter?** Or did you vote for someone who was not your first choice in order to fulfill a strategic ploy?

**Did you wish for some way to indicate your true opinions of the candidates** rather than being limited to selecting one or not voting? Under our current single-winner system, plurality voting, you get one vote, and the candidate with the most votes wins. While simple to understand, it can be frustrating. And **it doesn't have to be this way**.

Voting methods for winner-take-all elections go beyond **plurality**, to include **delayed runoff**, **approval**, **range or ranked choice voting** for a single seat. Which voting method you prefer will depend on which criteria you think are most important. Looking for change?

In a multi-member position, there are several election method choices.

**Bloc types** are traditional in the U.S.; examples include city council members that are elected at-large.

**Semi-Proportional** methods allow voters multiple votes in the same race. The top vote-receivers win the number of seats that are available.

**Proportional representation** methods allow voters to simultaneously elect multiple candidates for multiple seats in one race.

Other considerations include **the role of political parties** in how our elections are conducted, and the **impact on voting administration**, from hardware and software to training and voter education.

# **LWVOR LEGISLATIVE PROCESS DAY**

Looking Ahead to The Legislative Session - Alice Bartelt, Action Committee Chair

The beginning of the next legislative session will be here before we know it. The Action Committee will shift into high gear once the session opens. There could be as many as 3000 bills introduced, with the Action Committee following many of them. Those serving on the Action Committee are volunteers who put in many hours of work each week of the session.

The biggest issue that will be considered during the session will be the budget. Forecasts are that there will be at least a billion-dollar shortfall. How that problem will be resolved is the biggest question looming over the lawmakers. This problem will affect every state agency, many of which the League is concerned about. Perhaps the failure of Measure 97 will serve as a reason for the legislature to consider tax reform

Before the session starts, you will have the opportunity to learn how the Legislature works. Legislative Process Day (http://lwvor.org/event/legislative-process-day-2017/), on January 10, 2017 will feature the Clerk of the House of Representatives and the Secretary of the Senate. In addition, we will hear from Oregon's new Secretary of State, Dennis Richardson. It should be a very informative meeting, and the Action Committee will be there to answer your questions.

The League Board will be accepting member's Study Proposals for 2 year studies to be vetted and presented to the general membership at the Annual meeting. If you are interested in proposing a study a study scope, title and budget are required.

It also helps to have several members who are willing to help on the study.

Dear County Commissioners:

The League of Women Voters is a nonpartisan voter education and outreach organization. We do not support or oppose political candidates. After careful study, the League sometimes adopts positions on issues decided upon by our members.

The National League of Women Voters of the United States believes that natural resources should be managed as interrelated parts of life-supporting ecosystems. Resources should be conserved and protected to assure their future availability. Pollution of these resources of these resources should be controlled to preserve the physical, chemical and biological integrity of ecosystems and to protect the public health. League of Women Voters of Oregon 2016-2017 Positions

We believe that the League's position on natural resources supports securing permanent protection for the Oregon Redwoods for this and future generations.

We in Curry County are proud that the northernmost extent of the coast Redwood species is found on and near the Rogue River-Siskiyou National Forest in the upper Winchuck River watershed and in the watersheds of the Redwood, Big Redwood Creek, Emily, Little Emily and Mill Creek that all flow into the lower Chetco Wild and Scenic River.

In California, most redwoods were logged long ago. Almost all of what redwoods remain in California is permanently protected in national, state, and regional parks. Also magnificent and awe-inspiring, Oregon redwoods are not afforded comparable and enduring protection, but they should be.

The natural resources of Curry County are vital to the growing outdoor recreation economy. People come to visit our county to enjoy the weather, the water and the wild. Protecting the Oregon Redwoods would result in increased visitation in ways to sustainably enjoy them. Increased visitation would mean an expanded and diversified economy for Curry County.

Please join us in supporting permanent protection for the Oregon Redwoods by an act of Congress or other means.
