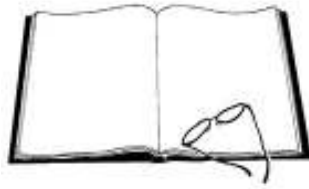
## Welcome New Members

## **Workforce Housing Project**

The Workforce Housing Project was started about two years ago to study the availability of affordable housing for the work force of Curry County. Their efforts, which were spearheaded by Wil Walkoe, involved the writing of a questionnaire and, using that questionnaire, interviewing employers, real estate professionals, developers and rental housing managers, government officials and others to find the kinds of housing that are available in Curry County. The data gathering is now complete. It is now time to draft the report that will be distributed throughout Curry County.

Wil met recently with new League members Dennis Knauert and Bob Horel to discuss the final presentation of the data. Both Dennis and Bob have the backgrounds that are needed for this task. They will be joined by another new League member, Tom Appleby. They will take the data that has been collected and turn it into a useable document for businesses and government to use for future planning. Many thanks to Wil for his diligence in guiding the project to this point. We look forward to seeing what our new members create and we thank them for stepping up to the task.

## **A Day in the Life of the Clinic**

Every Tuesday for the past 14 months, at 11:30AM, volunteers arrive to set up the clinic in the basement of St. Timothy's Episcopal Church. At the same time, the Tuesday Community Kitchen staff sets up to serve the food they have been preparing. Serving nearly 100 high-quality lunches takes plenty of preparation, so they have been busy for hours.

The patrons begin to arrive: some for lunch, some for medical assistance, some for both. Amid the clatter of dishes and hum of congeniality, Clinic staffers begin to take names, patients complete necessary paperwork, and the line continues to grow until the intake list reaches 20 to 30 names. People with various illnesses wait patiently, nervously, watching the door, anticipating, but not quite believing that it will open. At precisely 1PM it opens and into the Clinic they pour, gratefully, humbly, until the waiting room on the other side is full. Then they sit, again waiting, still uncertain that it is really true, worried that someone still might say there has been a mistake, that their paperwork is not in order or that the doctor is not in.

As patients take a seat in the waiting area, the clinical hustle and bustle has already begun. Volunteers: intake, outtake, social workers, nurses, medical practitioners and valued management and clerical staff buzz through the Clinic, nonstop, until the final patient has been seen. Sometimes it is 4:30, sometimes 5:30 or as late as 6:30PM. No matter. Everyone gets the attention they need. Exhausted, but gratified, the staff begins to fold up the Clinic operation and return it to its customary appearance as a church meeting room for church members, AA and other groups.

As the cleaning crew arrives to dismantle and disinfect, volunteers drift out and the scene returns to normalcy. What remains is the memory of grateful patients who were not forgotten or turned away, and feel better. New volunteers are always needed and appreciated.
