Gold Beach Unit Meeting

The attendance for the February Gold Beach Unit Meeting was light but the discussion led by Judge Jesse Margolis may have an impact.

Judge Margolis explained; how the court system works, the number of cases (4,139 Jan – Nov 20, 2014), how some are settled out of court, how guidelines work, alternatives and sentencing. During the discussion of alternatives it was revealed that Curry County has few due to lack of resources.Mental Health Court is moving forward but limited. When other treatment courts such as Veteran's Court was mentioned (not available in Curry County yet) LWVCC Member Connie Hunter (Brookings) did volunteer to work with Judge Margolis on this and other Veteran's court issues. Judge Margolis thanked the LWVCC for hosting the meetings. He spoke of sharing the LWV goal of having an informed public. Note: Curry Hospital District Board Member Rebecca Moore attended the Brookings Unit and was able to talk with Judge Margolis about Mental Health Issues.

Brookings Unit Meeting

Judge Margolis presented at the Brookings Unit Meeting on February 17th at 5:30 p.m. with 17 people in attendance. Jane Stebbins from the Curry Coastal Pilot brought Anastasia, an intern from Brookings Harbor High School. Also in attendance were League of Women Voters of Curry County members Yvonne Maitland, Marta West and Jessica Kensinger.

Some highlights from the presentation: There were 16 civil commitment cases in Curry County in 2014. Judge Margolis explained that for civil commitment in Oregon, the person has to not be able to meet their own basic needs or they are in danger to themselves or others.

Mental Health Court was also discussed at the meeting. Judge Margolis said that this court only meets needs of small number of people going through mental illness. Mental Health Court is also only open to people who are voluntarily cooperating.

INTRODUCING

LEAGUE OF WOMEN VOTERS OF OREGON: HARD ROCK MINING

STUDY PROPOSAL

Submitted by Alyssa Babin, Vice President, League of Women Voters of Curry County

TITLE: Reformation: Hard Rock Mining

SCOPE: The purpose is to study land based hard rock mineral mining in Oregon including: history, laws affecting operations, agency over sight, environmental effects of past and existing operations, and economic benefits and impacts on local communities.

OUTLOOK FOR WORK:

Analyze the costs and benefits of industrial hard rock mining in Oregon. Specific focus items for study could include: environmental impacts, investigating which state and federal agencies are charged with oversight of mining activities, which state and federal laws apply, the 1872 Mining Act, ideas to reform 1872 Mining Act, what materials are produced from mining used in Oregon, alternatives to mining and community costs and benefits.

The study will not include lacer, hydraulic, and recreational mining.

Currently, the League of Women Voters of Curry County has three members willing to be on a LWVOR study committee. We encourage and are actively seeking other broader league member participation. We have \$250 of contributions to the study through the education fund. We are currently researching more funding opportunities.
