

ANNUAL MEETING JUNE 14 AT 9:30 COUNTY FAIRGROUNDS GOLD BEACH

The League of Women Voters of Curry County will hold its Annual Meeting at Docia Sweet Hall at the Fairgrounds in Gold Beach on June 14th. There will be a social time from 9:30AM-10AM to meet and greet your fellow members! At 10:00 AM the business meeting will convene which includes a number of items, budget, bylaw proposals and elections. Lunch will be served around noon. Our guest speaker will be Mr. Jake Conde, Assistant District Attorney of Curry County. He will be discussing a serious situation that we should all be aware of. About 30% of the jail inmates are mental health clients who have gone off their medications and committed crimes. Sheriff Bishop confirms this proportion, which matches the statewide average. This important topic is one which all League members should be interested in because it is likely to be a major Public Safety issue in the months ahead. Educating our fellow citizens might be an important role for the League. Please come hear this important message so you can help guide our future.

- 4. Donations, direct mail appeal and/or donation jar appeals at all significant public meetings
- 5. Membership Dues, total of membership bills
- 6. Education Expenses, based on last year
- 7. Gift Memberships, proposed for three members
- 8. PMP, calculated exactly per January 31, 2014 count
- 9. Fundraising Expenses, amount could change based on chosen event
- 10. Surplus assumes profit from donations and fundraising of \$1000. Without that income we have a deficit of \$505.

PROPOSED BYLAWS AMENDMENTS

Text which has been deleted or replaced is shown with a strikethrough. Replacing or added text is shown in *italics*. Numerous typographical errors have been corrected and are not mentioned here.

Article III Section 2: (1) individuals who live within an area of a local League Curry County may join that League or any other local League;

Article IV Section 1: The officers of the LWVCC shall be a president, who shall be elected for a oneyear term; a first-vice-president, a second vice-president, a secretary and a treasurer who shall be elected for two-year terms. The first-vice-president and treasurer shall be elected in the odd numbered years and the second vice-president and secretary shall be elected in even numbered years.

Article IV Section 2: In the event of the absence, disability, resignation or death of the president, the first-vice-president shall assume the office until the end of the president's term. If the first vice-president is not able to serve as president, the board shall fill the vacancy until the end of the term from among the elected directors.

Article IV Section 3: The First-Vice-President. The first-vice-president shall assist the president in ways determined by the president and board. Article IV Section 4 is deleted and the subsequent articles renumbered.

Article V Section 1: The board of directors shall consist of the officers of the LWVCC, up to five directors elected by the annual meeting; (and not more than) four directors appointed by the elected members of the board.... All appointed directors shall serve until July 1st of the next year.

Article VI Section 1: There shall should be at least three one or more general membership meetings each year.

Article VII Section 1: The nominating committee shall consist of five members. The chair and two members, who shall not be members of the board but shall represent the three units, shall be elected for two-year terms in even numbered years at the annual meeting.... The board for the remainder of the term shall fill vacancies.

Article VIII Section 1: The Principles are concepts of government adopted by the national convention and supported by the League as a whole.

Article VIII Section 3: Any other changes in the program may be made provided the information concerning the proposed change has been sent to all members at least two weeks before a general membership unit meeting at which the change is to be discussed and that final action by the membership board is taken at a succeeding meeting.

Article IX Section 2: Annual dues shall be payable on May 1 July 1 of each year. Any member failing to pay dues by September 1 October 1 shall, after notification, be dropped from the membership rolls.

Article IX Section 4: To be added at the end of the current text: A paper copy of each board meeting's minutes shall be retained by the secretary. Paper copies of financial records shall be retained by the treasurer. Paper copies of studies, action, and reports shall be retained in files by the president.
