**President's Letter
(MJ LaBelle)**

Thanks also to Phil Dickson for administering our website again, to Anne Morgan who has agreed to help with Membership, to Hassie Taylor who will observe at some of the Commissioner meetings and to Renee Kolen who will again serve as chair of the Nominating Committee. My gratitude to all of you. "It takes a Village" of volunteers to run our LWVCC and these aren't the only ones. I will acknowledge all our observers and Unit Chairs in a later newsletter. They are the arteries through which we grow and nourish ourselves and our communities.

We began the year, as we always do, with a retreat, where we plan the new year's projects. Above is a photo of the Board standing with ten members of "Pedal the Pacific", a group who spoke to us about their commitment to raise funds to bring awareness to the dangers of sex trafficking. This group were young women between the ages of 18 and 22 from Texas, Arkansas, Alabama and Oklahoma. A different group rides from Seattle to San Diego every summer, usually stopping to rest, eat and wash clothes in Sixes. All monies raised go toward the shelter for girls rescued from sex trafficking. It is a privilege to host this wonderful group of young, strong and committed women. This year they raised over \$250,000.

I attended the LWVOR convention in Ashland this year. The issues of focus for 2019-2020 will be Oregon's 100 Year Anniversary of Women's Right to Vote; Climate Emergency, Redistricting and National Healthcare. These issues and more will be our focus this year.

PHS Teacher wins LWVUS Study Opportunity

The US League held an essay contest for High School Government and Social Studies Teachers. The prize was a three day all-paid trip to attend a workshop at Harvard Business School. Ms. Skinner's essay won in Curry County and this is the report she is sharing with us on her experience. You will be hearing more of this later this year as we plan a special County wide meeting with Ms. Skinner.

"A discourse on democracy was at the core of the Case Study Method workshop I attended at the Harvard Business School in August. The generous support of League of Women Voters chapters from across the country made this event possible for me and 70 other teachers. Thirteen of us were from Oregon. Acclaimed Professor David Moss lead the workshop in which we learned to incorporate the case study method that has long been used at Harvard Business School. I am eager to bring these cases that focus on various aspects of the development of democracy in the United States to my government and history classes at Pacific High School. I am also very much looking forward to facilitating a community case study event this spring to increase discussion of our democracy's history here on the South Coast."

Central County Unit Discusses Floras Lake, Upcoming Gun Workshop, Timber Removal

Members voiced concerns regarding a proposed timber removal project on Grizzly Mountain. Will the harvest put chemicals into the Rogue River? Gold Beach and Nesika Beach get their water from the Rogue.

The Floras Lake workshop produced concerns regarding a possible change in the Commissioner's position to do a land swap with Oregon State Parks. Commissioner Paasch talked about selling the land to a corporation (Shell or Jordan Cove proponents) for mitigation. Previous commissioners had agreed with the Lands Committee and north county residents that a swap with State Parks would be the best solution. Next hearing is on June 5.

The Gun proposal that would override State and Federal law was having another workshop Wednesday, April 24.

Census Information - LWVUS

The Constitution requires the government to conduct a census every 10 years. The goal is clear: to count all people living in the United States without exception—adults and children, citizens and non-citizens alike.

By the Census Bureau's own analysis, adding a citizenship question would stop approximately 6.5 million people from participating. If people are not counted, our communities will receive fewer resources for critical infrastructure like roads, schools, hospitals, libraries, and other programs people rely on every day. People will have less representation in government if there's an inaccurate census count.

CoastLines Editor Needed - Job Description

CoastLines is the LWVCC newsletter published at the beginning of our year of activities (September) through May with the exception of December (8 editions). Its primary purpose is to disseminate information, regarding league activities to our members from the Board and committees. The template is now in *Word*, but past issues have been developed in *Microsoft Publisher*. We no longer print issues monthly but send via email and occasionally print editions for special meetings. We continue to have a number of sponsors, at a low yearly cost to them, to cover any expenses.

Each issue of *CoastLines* is assembled by inserting the desired text and pictures into an existing *Word* template that gives the layout for 9 pages. Page 1 has the banner, volume, issue and date and lead stories. Page 2 has the Board info and President's Message. Pages 3&4 have articles, page 5 has the calendar, pages 6&7 has space for sponsors, page 8 has a mailing space (just in case) and a copy of the membership form.

Job Description - The editor needs to have good basic computer skills for uploading and downloading documents and pictures with Word into the template. Some writing is involved. Once completed the draft is sent to someone to review for typos. The corrected version is sent to the President (spokesperson for the LWV) for final approval. The President checks to be sure the issue is free of partisan remarks and the information is correct. Once this is done, *CoastLines* is converted to a PDF file and emailed to our membership, LWVOR, LWVUS, local league presidents, sponsors, elected officials and potential members. This is done with the push of a button.

LWV Curry County Recommended Study Proposal

Title: Revisiting the Feasibility of Recycling in Curry County

Scope: The purpose of this re-study is to address significant changes since the original study, "Economic Feasibility Recycling in Curry County." This study update will include: current recycling data, the evolution of recycling in the US and Curry County and will explore potential solutions to existing barriers to recycling that stem from feasibility, markets, logistics and consumer sentiment towards recycling. It will also include what challenges need to be addressed, how to address the proliferation of plastics locally and changes in the recycling supply chain.

Outlook for Work: The possible activities will be to: research and update the previous study; investigate what other communities facing similar challenges are doing and potential solutions; and explore alternative recycling for specific classes of materials with CTR. This study update and refinement will likely take more than one year depending upon the feasibility of CTR being able to adequately address these challenges. We intend to publish the report at the conclusion of the re-study.
